## **Three Jurupa Community Services District Board Directors Sworn In**

Director Herda holds a Master of Business Administration with a concentration in Strategic Analysis from Azusa Pacific University, a Bachelor of Science degree in Civil Engineering from Sacramento State University, and a Bachelor of Music degree in Music Composition from the University of Southern California.
