**COVID-19 Update  
Jurupa Community Services District (JCSD) Services and Programs**

*Jurupa Valley, CA* (March 18, 2020) - The health and safety of our residents and employees remains our highest priority. In response to this rapidly developing situation, we are carefully monitoring state and national advisories regarding COVID-19. On March 16, 2020, the JCSD Board of Directors proactively implemented several steps to protect the community and employees.

To ensure all customers have access to water during these challenging times, all late fees and disconnections will be suspended for one month.

An Emergency Proclamation was adopted by the Board of Directors. Should it become necessary, this enables JCSD to request mutual aid and be eligible for emergency funding.

**Water and Sewer Operations** - Water and sewer operations are proceeding normally. We conduct drills and meetings throughout the year as part of our normal business routine to plan for emergencies. Management and staff in all departments have met several times in the last few weeks to further discuss and plan for a more dire situation. Contingency plans have been made to keep employees healthy and ensure that our core services of water and sewer are not compromised.

**Tap Water** – JCSD tap water meets all state and federal drinking water standards. It is safe to drink.

**JCSD Headquarters** – The JCSD headquarters lobby will be closed to the public effective March 17, 2020. Please use the following methods to contact customer service or pay your bill:

**Parks and Recreation** - JCSD will temporarily close all recreation programs, the Splash Pads at Dairyland and Cedar Creek Parks, all building and sports field rentals and all facilities (Eastvale Community Center and Harada Neighborhood Center) through April

30, 2020. We will be cancelling any corresponding reservations from March 16th through April 30th, 2020. Refunds will be automatically returned to your account.
