JURUPA COMMUNITY SERVICES DISTRICT (JCSD) REFINANCES BONDS AND LOWERS PROPERTY TAXES

JURUPA VALLEY, CA (July 13, 2020) – In an effort to continuously provide cost effective service, the JCSD Finance team recently completed two important department objectives:

- Water and Sewer Revenue Bonds Originally issued in 2010 to finance necessary infrastructure, refinancing enables JCSD to save \$1,100,000 over the life of the bond in debt service costs.
- Community Facilities Districts (CFD's) Refinancing JCSD has completed the refinancing of eight CFD's for a total savings of \$7,879,611. Many newer communities, such as Eastvale, require the construction of infrastructure including parks, streetlights, and connections to water and sewer systems. CFD's, also known as Mello-Roos, levy special property taxes paid by homeowners for the construction of such infrastructure. The refinancing of the existing CFD bonds does not extend the original repayment terms.

"Now more than ever, fiscal responsibility is at the core of JCSD's mission. Reducing debt service costs and refinancing existing debt whenever there is an opportunity to save money is one example of JCSD's ongoing commitment to ratepayers." stated General Manager Chris Berch. "JCSD Finance staff continuously looks for new methods to provide the best possible value to our customers. In this instance, the reduction in the annual tax bill will range from \$285 to \$407 per parcel for these specific CFD's."

These CFD's will have a reduced special tax levy beginning with the 2020-21 property tax bill:
